

## RULES & REGULATIONS:

### WOLF STEEL'S BUY A GRILL AND WIN BIG CONTEST

This contest is presented by Wolf Steel Ltd. (Napoleon), the Contest Organizer.

The Contest is an in-store and online promotion where entrants can enter for a chance to win their purchase on Napoleon Rogue® SE grills purchased at The Home Depot retail stores in Canada (excluding Quebec) or [www.homedepot.ca](http://www.homedepot.ca). No Purchase Required entry also available.

#### 1. ELIGIBILITY

To be eligible for the Buy a Grill and Win Big Contest, entrants must:

- Have reached the age of majority at the time of entering the Contest

The Home Depot Gift Card pre-loaded with the amount you paid for the Napoleon Rogue SE (before taxes) will be mailed to you via secured mail. The prize must be accepted as awarded.
